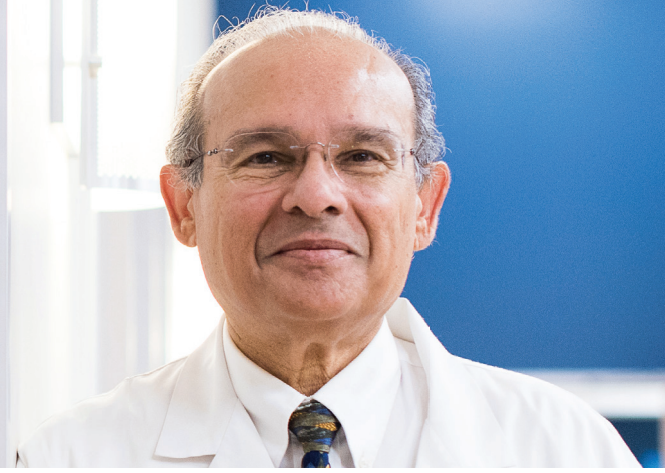


# A New Vision for Kidney Care in Minnesota

Our goal is to help prevent and delay the progression to kidney failure. If necessary, we aim to help patients choose preemptive transplant, planned outpatient or home start on dialysis or conservative therapy when appropriate.

In Minnesota, DaVita has 47 dialysis centers and 18 home programs, more than any other provider<sup>1</sup>, offering patients access to the kidney care and resources they need.
